## CE 1101 CHST Exam Prep Course

---

This course will prepare students for all competencies covered in the Construction Health and Safety Technician offered through the Board of Certified Safety Professionals. This certification is for individuals who demonstrate competency and work part-time or full-time in health and safety activities devoted to the prevention of construction illnesses and injuries.

Students will work through 7 units of lecture-based modules with practice problems and assessments to test knowledge. A downloadable workbook of practice problems will be sent to students upon course completion to continue study efforts before testing.

**Prerequisites:** Although there are no course prerequisites, we recommend that students have a TI-30XIIS calculator before beginning course work.

**CEUs Earned: 3.3**

## CE 1102 Industrial Hygiene for Safety Professionals

---

Industrial hygienists use environmental monitoring and analytical methods to detect the extent of worker exposure and employ engineering, work practice controls, and other methods to control potential health hazards.

This course was designed to enhance the skills of and provide the knowledge needed to successfully develop, administer, and evaluate occupational safety & health programs.

**Prerequisites:** None

**CEUs Earned: 5.5**

## CE 1103 ASP Exam Prep Course

---

This course will prepare students for all competencies covered in the Associate Safety Professional Examination offered through the Board of Certified Safety Professionals, which include trigonometry, chemistry, physics, statistics, safety management, fire prevention and protection, occupational health and more.

Students will work through 8 units of lecture-based modules with practice problems and assessments to test knowledge. A downloadable workbook of practice problems will be sent to students upon course completion to continue study efforts before testing.

**Prerequisites:** Although there are no course prerequisites, we recommend that students have a TI-30XIIS and/or an HP 10bII+ Calculator before beginning course work.

**CEUs Earned: 3.6**

## CE 1104 CSP Exam Prep Course

---

This course will prepare students for all competencies covered in the Certified Safety Professional Examination offered through the Board of Certified Safety Professionals, which include advanced science and math, risk management, emergency preparedness, law and ethics, advanced safety concepts and more.

Students will work through 8 units of lecture-based modules with practice problems and assessments to test knowledge. A downloadable workbook of practice problems will be sent to students upon course completion to continue study efforts before testing.

**Prerequisites:** Although there are no course prerequisites, we recommend that students have a TI-30XIIS and/or an HP 10bII+ Calculator before beginning course work.

## CE 1105 Maritime Hazardous Material Inventory

---

The 2009 Hong Kong Convention for the Safe and Environmentally Sound Recycling of Ships aims to ensure that vessels, upon being recycled at the end of their operational lives, do not present any unnecessary hazards to human health, safety, nor the environment. This course was designed to assist the student in becoming familiar with the requirements of the 2009 Hong Kong Convention. These requirements will become law effective, in 2020, for all vessels over 500GT.

This course is a 10 week, self-paced, open enrollment course. Once students complete each assignment in the course with a 70% or higher, they will receive a certificate of completion that will list the 4.0 CEUs earned.

**Prerequisites:** None

**CEUs Earned: 4.0**
